Request for Official Information: Funding for Applicant Groups under Te Takutai Moana Act 2011 and Ngā Rohe Moana o Ngā Hapū o Ngāti Porou Act 2019 (the Acts)

Thank you for your correspondence of 17 May 2024 requesting the following under the Official Information Act 1982 (OIA):

I would like the following information on those who have or are progressing an application under the Takutai Moana Act 2011 and the Ngā Rohe Moana o Ngā Hapū o Ngāti Porou Act 2019. This request covers both the Court and Crown pathways and should total more than 500 applications.

The information requested:

For each application, I would like the: MAC/CIV/IP number; the Applicant Group Name; the total amount ex GST that has been Applied For, Approved, Paid under each Workstream (Activity, Court, Collaboration); and finally the total Paid under any previous payment scheme.

I would like this delivered in a format suitable for filtering, summarising, or calculating totals, e.g. a spreadsheet.

Further correspondence with you has clarified that the request is refined to an end date of 29 February 2024.

A response to your request is set out below. Based upon the details of your request, a spreadsheet containing information on funding provided to applicant groups has been compiled, and is shared along with this response letter. We are providing it in both PDF format as a record of the data provided, and in the form of a spreadsheet in accordance with your request.

The spreadsheet contains the following information for each applicant group:

- MAC/CIV/IP number – note for groups that have applications submitted to both the High Court and the Crown Engagement pathway of the Acts, both numbers are listed, with the CIV number listed first;
- Applicant Group Name;
- Total funding provided by the Takutai Moana Financial Assistance Scheme for the purposes of the application under each of the Activity, Court, and Collaboration workstreams since the implementation of the workstreams in 2023, and including all funding paid for requests received up to 29 February 2024;
- Total funding provided for the purposes of the application under the Takutai Moana Financial Assistance Scheme prior to the implementation of the workstreams; and
- The total funding provided (a sum of the 4 columns).

You have requested the total amount of funding approved and paid under each workstream. All requests for funding received by 29 February 2024 that have been approved have also been paid, so the information provided in response to these requests is identical.

You have also requested the total amount of funding that has been applied for. Funding is requested by applicant groups by the submission of invoices for costs incurred, or the submission of an invoice in accordance with a Funding Agreement in the case of an approved request for small grant funding. These invoices are saved by Te Arawhiti in bundles which are processed as a funding request. In some cases, an invoice may be saved in multiple funding requests. This may be for a number of possible reasons – for example, it may have been resubmitted at Te Arawhiti's request due to information missing in the previous request. Only one instance of the invoice is approved and paid in these cases.

Due to the aforementioned duplication of received invoices in our records, the only way to accurately represent actual costs applied for would be to cross-reference all individual invoices received to remove duplicate costs. Due to the amount of work that is required to collate this information (we estimate several hundred hours), we are refusing this portion of your request under Section 18(f) of the OIA as the information cannot be made available without substantial collation or research.

Please also note that all payments made under the Takutai Moana Financial Assistance Scheme are exempt from GST, and therefore are all exclusive of GST.

When Te Arawhiti acknowledged receipt of your OIA request, we advised we may proactively release your OIA response on our website.

After considering our response to your request, we can advise that it will be published no earlier than 20 working days from the date of this letter at www.tearawhiti.govt.nz. As discussed with you, we will disclose your name as this has been requested by applicants and is the subject of an OIA request. We do not consider that it is necessary to withhold your name under (section 9(2)(a)). Other identifying information will be removed.
