## 1. BACKGROUND

- A. Ahuriri Hapū, the trustees of the Mana Ahuriri Trust (“trustees”) and the Crown are parties to:
- (1) a deed of settlement dated 2 November 2016;
  - (2) a deed to amend the deed of settlement dated 16 February 2017;
  - (3) a second deed to amend the deed of settlement dated 13 June 2017; and
  - (4) a third deed to amend the deed of settlement dated 6 December 2021,
- (together, “**Deed of Settlement**”).
- B. The trustees and the Crown wish to enter this deed to formally record certain amendments to the Deed of Settlement, in accordance with clause 5.1 of the General Matters Schedule to the Deed of Settlement.

IT IS AGREED as follows:

### **EFFECTIVE DATE OF THIS DEED**

- 1.1 This deed takes effect when it is properly executed by the parties.

### **AMENDMENTS TO THE DEED OF SETTLEMENT**

- 1.2 The Deed of Settlement:

- 1.2.1 is amended by making the amendments set out in Schedule 1 to this deed; but
- 1.2.2 remains unchanged except to the extent provided by this deed.

- 1.3 For the avoidance of doubt, the following deferred selection periods remain unchanged:

- 1.3.1 2 years, in relation to the deferred selection property referred to as “Ahuriri Station”;  
and
- 1.3.2 3 years, in relation to the Unlicensed land.

### **DEFINITIONS AND INTERPRETATION**

- 1.4 Unless the context otherwise requires:

- 1.4.1 terms or expressions defined in the Deed of Settlement have the same meanings in this deed; and
- 1.4.2 the rules of interpretation in the Deed of Settlement apply (with all appropriate changes) to this deed.

**COUNTERPARTS**

- 1.5 This deed may be signed in counterparts which together shall constitute one agreement binding on the parties; notwithstanding that both parties are not signatories to the original or same counterpart.
