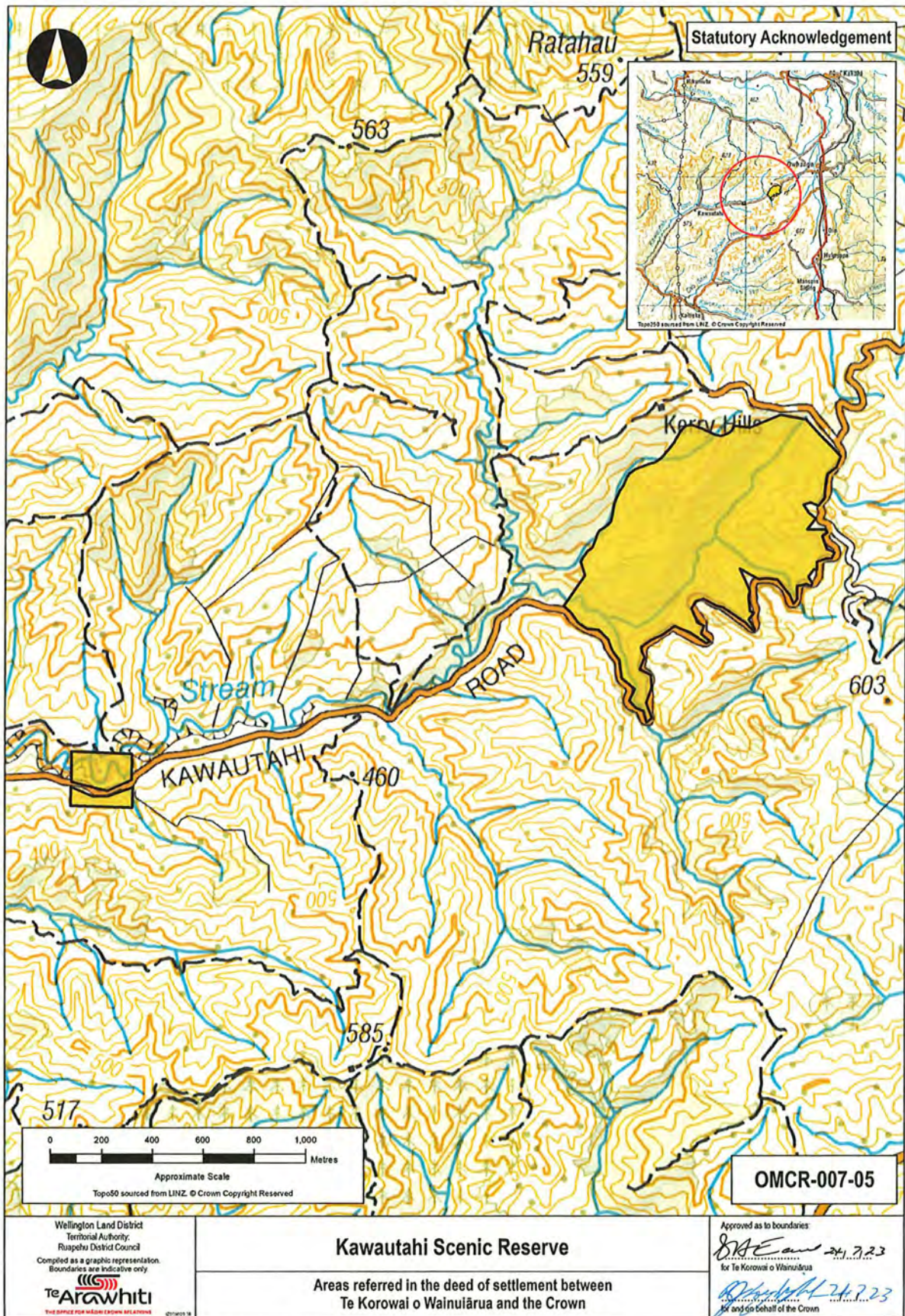
Hawkin's Wetland Scenic Reserve
