

## INTRODUCTION

The Cultural Redress Schedule (Schedule 1), the Commercial Redress Schedule (Schedule 2), the Deed of Covenant (Schedule 3), the Area of Interest (Schedule 4), the Taranaki Land District (Schedule 5), and the SO Plans (Schedule 6) form part of the Deed of Settlement of the Historical Claims of Ngāti Mutunga entered into between Ngāti Mutunga and the Crown.
