**Tumutumu property**

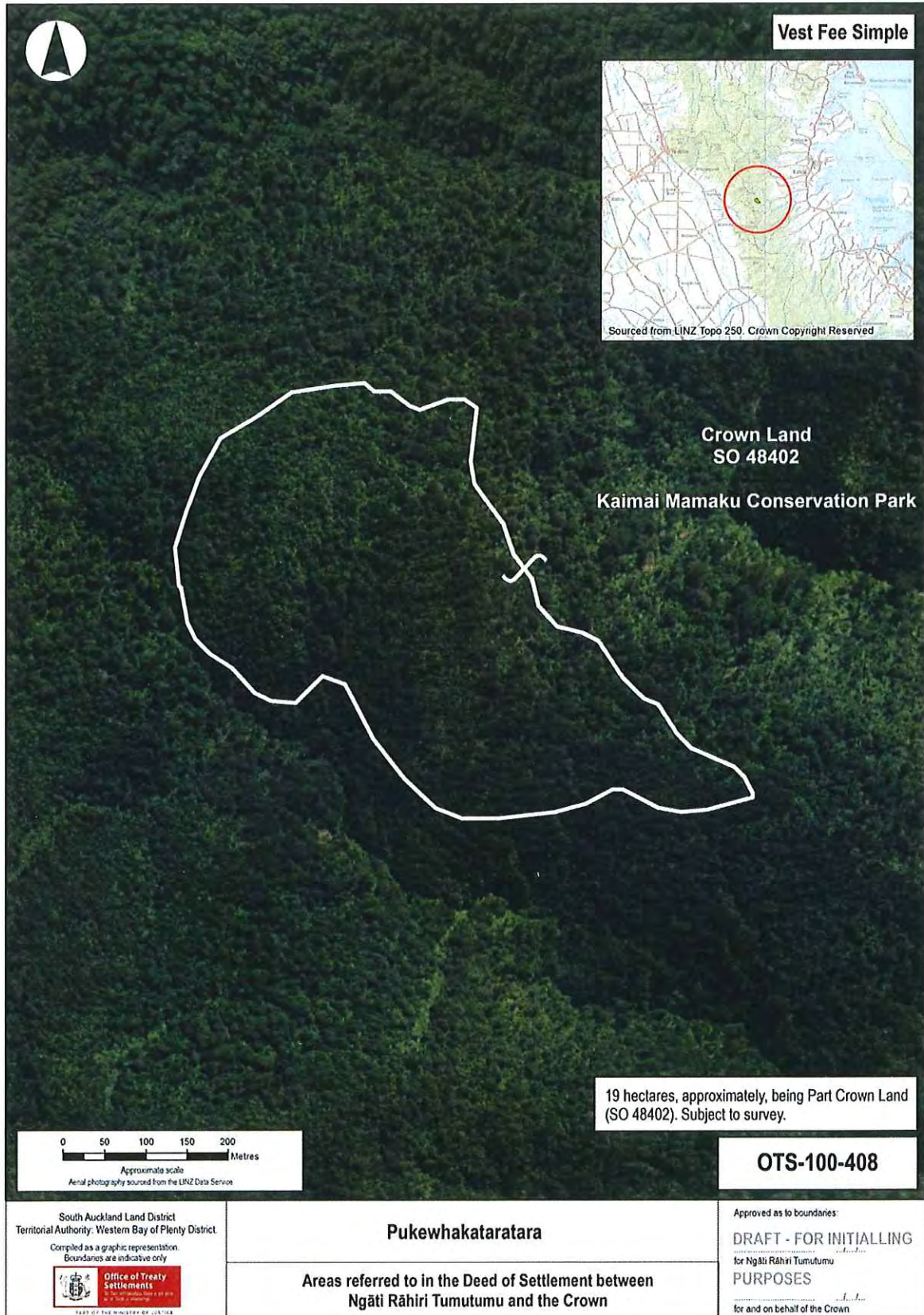
