DEED TO AMEND NGĀTI KURI DEED OF SETTLEMENT

THIS DEED is made on the 21 day of December 20 15

BETWEEN

NGĀTI KURI

AND

TE MANAWA O NGĀTI KURI TRUST ("the governance entity")

AND

THE CROWN

1. BACKGROUND

- A. Ngāti Kuri and the Crown are parties to a:
- A.1 Deed of Settlement dated 7 February 2014;
 - A.2 Deed to Amend the Ngāti Kuri Deed of Settlement dated 10 September 2014;
 - A.3 Deed to Amend the Ngāti Kuri Deed of Settlement dated 24 April 2015; and
 - A.4 Deed to Amend the Ngāti Kuri Deed of Settlement dated 30 July 2015,
- (together, the “**Deed of Settlement**”).
- B. Te Manawa o Ngāti Kuri trustees and the Crown wish to enter this deed to formally record certain amendments to the Deed of Settlement, in accordance with clause 4.1 of the General Matters Schedule to the Deed of Settlement.

IT IS AGREED as follows:

EFFECTIVE DATE OF THIS DEED

- 1.1 This deed takes effect when it is properly executed by the parties.

AMENDMENTS TO THE DEED OF SETTLEMENT

- 1.2 The Deed of Settlement:
- 1.2.1 is amended by making the amendments set out in Schedule 1 to this deed; but
 - 1.2.2 remains unchanged except to the extent provided by this deed.

DEFINITIONS AND INTERPRETATION

- 1.3 Unless the context otherwise requires:
- 1.3.1 terms or expressions defined in the Deed of Settlement have the same meanings in this deed; and
 - 1.3.2 the rules of interpretation in the Deed of Settlement apply (with all appropriate changes) to this deed.

COUNTERPARTS

- 1.4 This deed may be signed in counterparts which together shall constitute one agreement binding on the parties, notwithstanding that both parties are not signatories to the original or same counterpart.
