## 1. BACKGROUND

- A. Te Rarawa and the Crown are parties to a:
- A.1 Deed of Settlement dated 28 October 2012;
  - A.2 Deed to Amend the Te Rarawa Deed of Settlement dated 12 March 2014; and
  - A.3 Deed to Amend the Te Rarawa Deed of Settlement dated 9 April 2014,
- (together, the "**Deed of Settlement**").
- B. Te Rūnanga o Te Rarawa trustees and the Crown wish to enter this deed to formally record certain amendments to the Deed of Settlement, in accordance with clause 4.1 of the General Matters Schedule to the Deed of Settlement.

**IT IS AGREED** as follows:

### EFFECTIVE DATE OF THIS DEED

- 1.1 This deed takes effect when it is properly executed by the parties.

### AMENDMENTS TO THE DEED OF SETTLEMENT

- 1.2 The Deed of Settlement:
- 1.2.1 is amended by making the amendments set out in Schedule 1 to this deed; but
  - 1.2.2 remains unchanged except to the extent provided by this deed.

### DEFINITIONS AND INTERPRETATION

- 1.3 Unless the context otherwise requires:
- 1.3.1 terms or expressions defined in the Deed of Settlement have the same meanings in this deed; and
  - 1.3.2 the rules of interpretation in the Deed of Settlement apply (with all appropriate changes) to this deed.

### COUNTERPARTS

- 1.4 This deed may be signed in counterparts which together shall constitute one agreement binding on the parties, notwithstanding that both parties are not signatories to the original or same counterpart.

AMENDMENTS TO THE DEED OF SETTLEMENT

Deed of Settlement

Current part and reference	Amendment
Part 9, clause 9.41	Replace clause 9.41 with the following:  9.41 Clause 9.42 applies in respect of Pukepoto School if, before or on the settlement date, the board of trustees of Pukepoto School relinquishes the beneficial interest it has in the Pukepoto school house situated on that site (" <b>Pukepoto School house site</b> ").
Part 9, clause 9.48	The following amendment is made to the fourth column of the table in clause 9.48:  Replace "AW26 352729" with "AW26 350729" as the location of the feature with the existing geographic name "Rangi Point".
Part 10, new clause 10.8A	Insert, after clause 10.8, a new clause 10.8A as follows:  "10.8A.1 The parties acknowledge that the transfer value of the Te Kura Taumata o Pangaru School House site (\$2,000) was not held back when the Crown paid the remaining financial and commercial redress amount described in clause 10.1 to the Te Rūnanga o Te Rarawa trustees.  10.8A.2 On settlement date the Crown will deduct \$2,000 from the interest payment described in clause 12.2.2 to account for the value of the Te Kura Taumata o Pangaru School House site."
Part 12, clause 12.2	Insert the following at the beginning of clause 12.2:  "Subject to clause 10.8A,"
