DEED OF SETTLEMENT

November 1996

Deed of Settlement: Amendment No. 2

THIS DEED is made on the day of November 1996

BETWEEN

- (1) **HER MAJESTY THE QUEEN** in right of New Zealand acting by the Prime Minister
- (2) **WAIKATO**

BACKGROUND

- A. The Crown and Waikato are parties to a Deed of Settlement dated 22 May 1995 (which in its form amended by a Deed to Amend in November 1995 is referred to below as the "Deed of Settlement").
- B. The Crown and Waikato wish to amend the Deed of Settlement in the manner described in Clause 30 of the Deed of Settlement.

ACCORDINGLY, the Crown and Waikato agree as follows:

1 DEFINITIONS AND INTERPRETATION

Except as otherwise provided in this Deed or unless the context otherwise requires, terms defined in the Deed of Settlement have the same meaning in this Deed and the rules of interpretation set out in the Deed of Settlement will apply in the interpretation of this Deed.

2 AMENDMENTS TO ATTACHMENT 2 AND ATTACHMENT 3

The Deed of Settlement is amended by:


- 2.1 replacing those descriptions of Settlement Properties in Attachments 2 and 3 where the Agency referred to in Column 4 is "CoalCorp" or "Crown-CoalCorp" with the details set out in *Appendix 1* to this Deed; and
- 2.2 replacing those descriptions of Settlement Properties in Attachments 2 and 3 where the Agency referred to in Column 4 is "RailCorp" with the details set out in *Appendix 2* to this Deed.

3 **AMENDMENT TO CLAUSE 8**

- 3.1 Subject to Clause 3.2 below, Clause 8.2 of the Deed of Settlement has effect, in respect of the Settlement Properties for which the Agency referred to in Column 4 of Attachment 2 and Attachment 3 is "Crown-CoalCorp" or "CoalCorp" (as amended by this Deed), as if the date by which the election to be made under Clause 8 of the Deed of Settlement were 13 December 1996.
- 3.2 Clause 8.2 of the Deed of Settlement applies without amendment to the CoalCorp Land.
- 3.3 Clause 8.2 of the Deed of Settlement has effect, in respect of the Settlement Property described as "CF1" in Column 9 of Attachment 2 (Maramarua Forests) and the Settlement Properties for which the Agency referred to in Column 4 of Attachment 3 is "Land Corp", as if the date by which the election to be made under Clause 8 of the Deed of Settlement were 31 December 1996.

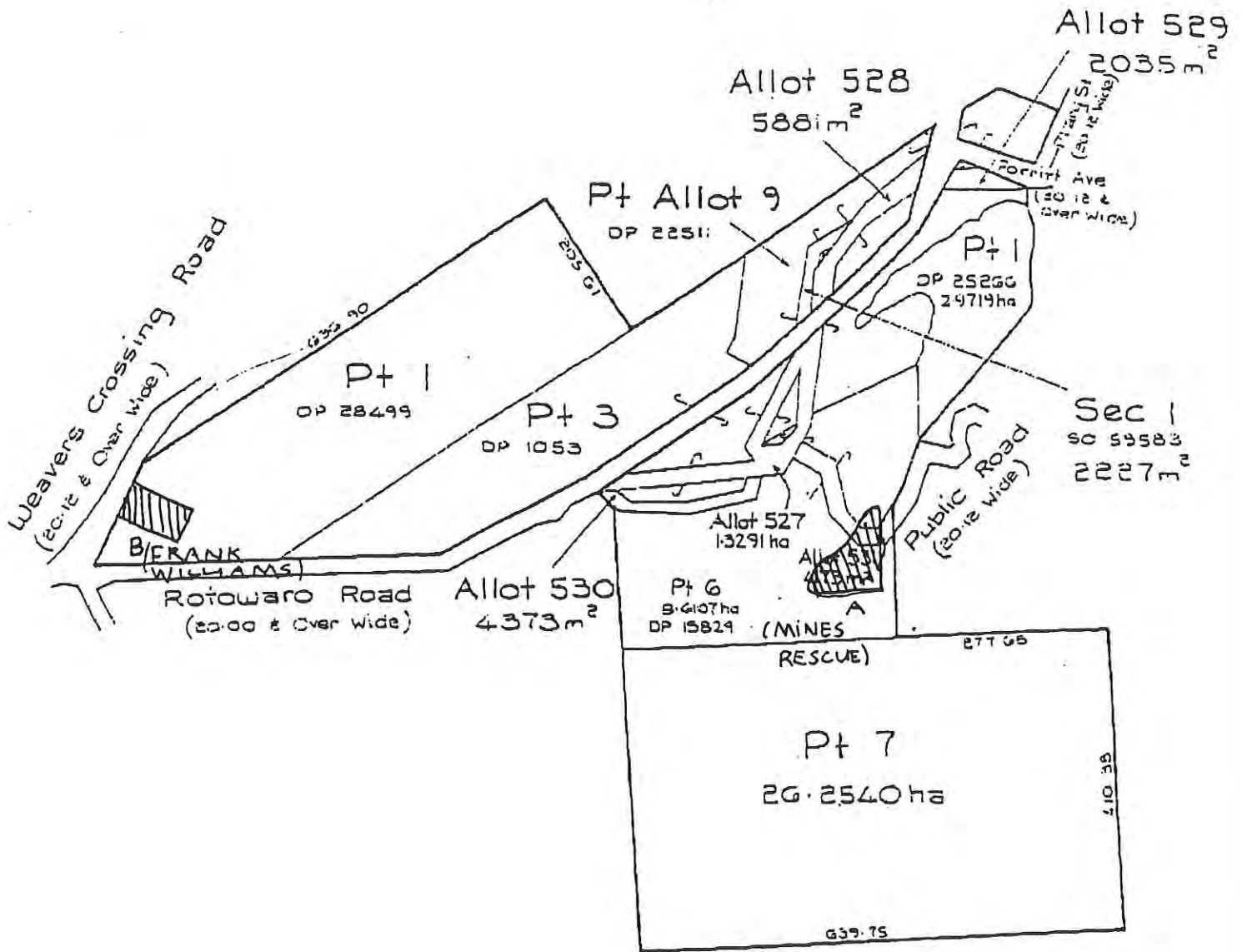
